In order to help all students meet the Missouri Learning Standards, Halfway Junior/Senior High School will provide supplemental instruction in the classroom, outside of the classroom with small group and individual instruction, and before and after school tutoring. Data teams will meet to evaluate which students meet the criteria for pull-out and tutoring. Response to Intervention will be utilized to help students meet the requirements of the Missouri Learning Standards. Again, data teams will be used to analyze the criteria regarding which students are in RTI.

In addition to the data tracking which happens in classrooms, students will be universally screened and progress monitored when appropriate in order to see what strategies are working and when strategies need to be changed or are no longer needed. When students are in charge of their goals and tracking their progress, we have seen great motivation and improvement. The goal will be to move students out of tutoring and interventions.
